# EAST MODESTO FORUM [KEY FINDINGS]

#### **Segment Definition**

Geographic classification of community members who live in zip codes 95355 and 95351 (East Modesto/Airport Neighborhood) and have a vested interest in their neighborhood's health, well-being, advancement, and success.

#### **Meeting Context**

# **Topline Findings**

<u>Question 1:</u> What do you like most about Modesto?

The most popular responses shared by community members were:

(1) The city's outdoor amenities. Community members appreciate the city's parks, baseball fields, the river, parking access, and other outdoor areas.

(2) Job opportunities. Attendees in East Modesto, predominantly Spanish speaking with an immigrant base, value access to livable wage job opportunities.

(3) Robust support services. Access to donations (e.g., food and clothing) in East Modesto and the rest of the city is plentiful and something that some families in the community have come to depend heavily on. Some participants described how residents in Modesto have more access to these services than in other cities in Northern California.

# Question 2:

What would you like to see changed in Modesto to make it a better place to live and work?

Most responses were related to three critical improvements:

(1) Safety concerns. Community members highlighted three safety concerns for this neighborhood: (a) homelessness in public parks; (b) gang members and unsafe drivers that make being outside at night dangerous; and (c) slow response times and aggressive behavior from police.

(2) Quality of infrastructure. East Modesto residents are concerned about the poor road quality and the lack of sidewalks, sewers, and speed bumps in their community. The inadequate infrastructure in East Modesto is a critical quality of life and safety issue for the community.(3) Cost of living. Higher costs for gas, public transportation, rent, and leisure are affecting the community members' ability to thrive. They feel that there is no other place for them to move if costs continue to increase, so they hope that prices will go down or income could increase.

# Question 3:

Senate Bill 1000 requires the City to improve a range of conditions in disadvantaged communities. Specifically, we need to develop policies to address the topics listed below. What do you see as the key issues related to these six topics in Modesto? Are there other aspects to environmental justice you would like to see the General Plan address?

**Pollution Exposure and Air Quality:** Yosemite Avenue and Mitchell Road are home to many industrial companies; community members feel that living close to them may cause health issues (e.g., worsening asthma) and noise pollution. They also stated that abandoned warehouses bring in more homeless people.

**Public Facilities and Services:** Community members would like to see more lighting on roads to make walking at night safer. They would also like the "Power that Be" to make a plan to remove homeless camps from parks, so children and families feel safe to use them.

**Food Access:** Community members desire more grocery store options near Kerr Avenue. The lack of a pharmacy in the area also makes managing health difficult, especially with an aging population.

**Safe and Sanitary Homes:** Community members feel that there are many dilapidated houses that create a negative perception of the area. They believe this problem has gotten worse throughout the years, even before the pandemic. They also feel there is a garbage problem in the neighborhood, with residents using front lawns as dumps and people littering throughout the streets.

**Physical Activity:** Parents would like to see more walking and biking trails for students attending Orville Wright Elementary. The area currently lacks sidewalks, which is a safety concern.

**Community Engagement:** Community members requested that City and County representatives be more present in the neighborhood. They feel there is a lack of communication and relationship between governmental leaders and community members.

#### Question 5:

Should future development be focused as infill development (i.e., to already developed areas), or should it be allowed to extend beyond the current city limit? If beyond the city limit, where should that be allowed?

Community members discussed both housing and commercial expansion: Most community members would like the City to annex the unincorporated areas of Airport Neighborhood because they view it as a way to get critical infrastructure updates in the area. They think more housing could be built in West and South Modesto, preferring infill development over building in undeveloped land in the City's Sphere of Influence. The priority for community members is using vacant land, such as the abandoned warehouses by the airport and deteriorated lots that have gone unused for years.

# Additional Insights from Debrief's East Modesto Partners

This section provides additional contextual understanding from Debrief's community-based relationships and current project engagements.

- Modesto City Schools' parent resource center is under new leadership in East Modesto. The parent resource center, near Orville Wright Elementary, hired a new lead administrator this year and is in the process of building relationships with the community.
- 2. Large nonprofit organizations in Airport Neighborhood bring in people who live outside of the neighborhood. The Modesto Gospel Mission and Golden Valley Health Centers are two large nonprofit organizations located in Airport Neighborhood. The services they provide bring in people from outside of the area, which can deter community members from taking advantage of services and is viewed as exacerbating the homelessness problem.
